Pre-Medicare Meeting: 9:30am - 11:00am

This meeting is for those still enrolled on the PEBP Consumer Driven Health Plan (PPO), PEBP Premier Plan (EPO), or Health Plan of Nevada (HMO) who have not yet enrolled in Medicare and would like an overview of how to make that transition once they turn 65 or retire. Within the next year, if you will be turning 65 and/or enrolling in Medicare after you retire, the morning meeting will provide an overview of the enrollment process and timeframe, HRA funding, and PEBP's Medicare requirements.

If you are *already enrolled* through Via Benefits (formerly Towers Watson's OneExchange), you are not required to take any action. The afternoon meeting is for informational purposes only and will explain how to use the Health Reimbursement Arrangement (HRA) account to help pay for your out-of-pocket health care expenses and/or health care premiums.
