Dear PEBP Retiree,

Plan year 2022 open enrollment (OE) will be held May 1<sup>st</sup> - May 31<sup>st</sup>, 2021 for the Public Employees' Benefits Program (PEBP). PEBP will host all open enrollment meetings via live webinar on May 5<sup>th</sup> for Medicare Exchange retirees. Retirees and their eligible spouses enrolled in a **medical plan** through Via Benefits have the option to **newly enroll in PEBP dental or decline your current PEBP dental coverage**. To make changes, log on to your E-PEBP Portal at [www.pebp.state.nv.us](http://www.pebp.state.nv.us). If you need to reset your password, follow the password reset instructions on the PEBP website under [What's New](#).

Retirees and eligible spouses must be enrolled in a **medical plan** through Via Benefits in order to participate in PEBP dental. This does not apply to eligible TRICARE for Life retirees. Retirees are required to maintain medical coverage through Via Benefits in order to continue PEBP benefits.

Non-State Retiree Eligibility (NAC 287.542, 287.548): Non-state retirees are individuals who retired before November 20, 2008 from a PEBP participating local government, such as a city, county, or school district.

**Monthly HRA Contribution (effective July 1, 2021 – June 30, 2022)**

The monthly Health Reimbursement Arrangement (HRA) contribution will be \$11 per month, per

year of service (YOS). The following table reflects the HRA contribution amounts for eligible retirees. #### **How to determine your HRA contribution**

- Retirees who retired before January 1, 1994, receive the 15-year base contribution monthly.
- For participants who retired ON OR AFTER January 1, 1994, the monthly contribution is based on years of service. See table to the left.
- Participants who were hired after 2012 do not have a subsidy. Hired 2010-2012 you must have a minimum of 15 years to receive a subsidy or retire under a long-term disability plan.
- Spouse/domestic partners do not receive a contribution.

#### **Health Reimbursement Arrangement**

Plan provisions allow for a 12-month, 365-day, timely filing period for claims submission. The 365 days is measured from the date the services were incurred. No plan benefits will be paid for any claim submitted after this period.

#### **Important Information Regarding your Benefits**

Retirees and covered dependents, spouses, or domestic partners **MUST** continue to pay their Part B premiums and **stay enrolled** in a medical plan through Via Benefits in order maintain PEBP Benefits. Retiree benefits include: HRA funding, life insurance, dental, and voluntary benefits.

#### **Open Enrollment Meetings**

PEBP will be hosting a live webinar tailored specifically to Medicare retirees on May 5<sup>th</sup>. The dental plan design is not changing, and the new dental rates are on the previous page. During these webinars, you will be able to follow along with the presentation as well as ask a PEBP representative any questions you may have.
